

Elias Wick Terms and Conditions

Please read this Agreement carefully. It is a legal document that explains your rights and obligations related to your use of Elias Wick's Products and related Content. By purchasing, downloading or using any of Elias Wick's Products or any related Content, you are agreeing to be bound by the terms of this Agreement. If you do not or cannot agree to the terms of this Agreement, please do not purchase, download or use Elias Wick's Products or any related Content.

Certain words or phrases are defined to have certain meanings when used in this Agreement. Those words and phrases are defined in this document under Section 6.

If you are separately licensed by Elias Wick under a custom license, certain terms of this Agreement do not apply to your custom license. A custom license refers to an agreement between you and Elias Wick, or any sublicensor authorized by Elias Wick, other than this Agreement or any amendment to this Agreement, under which you are granted a license to use the Elias Wick Products and any related Content to develop one or more product(s), other than this Agreement.

Section 1. License Grant

Elias Wick grants you a non-exclusive, non-transferable, non-sublicensable license to use, reproduce, display, perform, and modify the Elias Wick's Product or any related Content for any lawful purpose. However, the rights that Elias Wick grants you under the license are subject to the terms of this Agreement, and you may only make use of the license if you comply with all applicable terms. Elias Wick reserves all rights not expressly granted to you under this Agreement.

You acknowledge that Elias Wick is the exclusive owner of any Elias Wick's Products and any related Content. You and Elias Wick are independent contractors and are not the legal representative, agent, joint venturer, partner, or employee of the other. Neither Party has any right or authority to assume or create any obligations of any kind or to make any representation or warranty on behalf of the other Party. You agree not to take any action that is in conflict with Elias Wick's rights or ownership of the Elias Wick's Products or any related Content. Elias Wick in its sole discretion may modify or terminate this Agreement at any time without notice. Elias Wick's waiver or failure to enforce a breach of any provision of this Agreement is not a waiver of that provision.

The license becomes effective on the date you accept this Agreement, or purchase, download or use any of Elias Wick's Products or any related Content. The license does not grant you any title or ownership for any of Elias Wick's Products or any related Content.

Section 2. User License

This section explains your rights and obligations related to your use of Elias Wick's Products or any related Content.

1. What can the Customer do with a Product?

- a. All Products sold on Gumroad are licensed to the Customer (who may be either an individual or company) for the lifetime right to use the Content in developing an unlimited number of products and in shipping those products. The Customer is also

licensed to make the Content available to employees and contractors for the sole purpose of contributing to products controlled by the Customer. Each such product built using Content purchased from Gumroad must be a standalone creative work (such as a game, simulation, or video) in which the Gumroad Product is merely a component and not the primary focus.

2. Can the Customer modify, resell or transfer a Product?

- a. Customers are free to modify any Products they purchase from Gumroad, but they may not transfer or sublicense those Products for further distribution on Gumroad, any other online store or physical store.

3. What do the Customer get when purchasing a Product?

- a. When Customers purchase a Gumroad Product, they get a non-exclusive, worldwide, perpetual license to download, use, copy, post, modify, promote, license, sell, publicly perform, publicly display, digitally perform, Distribute, or transmit Elias Wick's Products and related Content for personal, promotional, and/or commercial purposes. Distribution of Products via Gumroad is not a sale of the Product or related Content, but the granting of digital rights to the Customer.

Section 3. Limitation of Liability

YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT YOU ARE SOLELY RESPONSIBLE FOR (AND THAT ELIAS WICK HAS NO RESPONSIBILITY TO YOU OR ANY THIRD PARTY FOR) THE CONTENT DISTRIBUTED THROUGH THE GUMROAD WEBSITE AND FOR THE CONSEQUENCES (INCLUDING ANY LOSS OR DAMAGE WHICH ELIAS WICK OR ANY THIRD PARTY MAY SUFFER) OF SUCH DISTRIBUTION.

Section 4. Indemnification

To the maximum extent permitted by law, you shall defend, indemnify, and hold harmless the Elias Wick Parties from and against any and all third party claims, actions, suits, or proceedings, as well as any and all losses, damages, liabilities, costs, and expenses (including reasonable attorneys' fees and all reasonable related costs) arising out of or accruing from your content or your Brand Features, your breach any representation, warranty or other term of this Agreement, your customer service and other interactions with Customers, any contract you have entered into with any third party, or your violation of any applicable law or regulation.

Section 5. Feedback and Contributions

If you provide Elias Wick with any Feedback, Elias Wick is free to use the Feedback however it chooses. If you make any Contribution available to Elias Wick, you hereby assign to Elias Wick all right, title, and interest (including all copyright, patent, and other intellectual property rights) in that Contribution for all current and future methods and forms of exploitation in any country.

If any of those rights are not effectively assigned under applicable law, you hereby grant Elias Wick a non-exclusive, fully-paid, irrevocable, transferable, sublicensable license to reproduce, Distribute, publicly perform, publicly display, make, use, have made, sell, offer to sell, import, modify and make derivative works based on, and otherwise exploit that Contribution for all current and future methods and forms of exploitation in any country. If any of those rights may not be assigned or licensed under applicable law (such as moral and other personal rights), you hereby waive and agree not to assert all of those rights. However, you may continue to freely use any Feedback that you provide to Elias Wick, and you may continue to use, in any manner consistent with the license, any Contribution that you make available to Elias Wick.

You understand and agree that Elias Wick is not required to make any use of any Feedback or Contribution that you provide. You agree that if Elias Wick makes use of your Feedback or Contribution, Elias Wick is not required to credit or compensate you for your contribution.

You represent and warrant that you have sufficient rights in any Feedback or Contribution that you provide to Elias Wick to grant Elias Wick and other affected Parties the rights described above. This includes but is not limited to intellectual property rights and other proprietary or personal rights.

Section 6. Definitions

The section headings used in this Agreement are intended primarily for reference and shall not by themselves determine the construction or interpretation of this Agreement or any portion hereof.

As used in this Agreement, the following capitalized words have the following meanings:

“Agreement” means this Terms and Conditions Agreement.

“Brand Feature” means any trade name, trademark, service mark, logo, domain name, or other distinctive brand feature of each Party, respectively, as owned (or licensed) by such Party from time to time.

“Content” means any code, artwork, information, or other content that Elias Wick makes available to you for purchase, download or use from the Gumroad website.

“Contribution” means any information or Content, that you make available to Elias Wick by any means (e.g., via submissions, posts or comments on forums, or through email or otherwise).

“Customer” means any natural person, company, or other legal entity that will acquire a license to use any Content.

“Distribute” means to provide or otherwise make a copy available, or to make its functionality available on a network.

“Elias Wick” means the Elias Wick corporation operating in Sweden, Stockholm.

“Feedback” means any feedback or suggestions that you provide to Elias Wick regarding Elias Wick’s Products or related Content.

“Gumroad” means an online marketplace, also known as an e-commerce platform, owned and operated by Gumroad which permits the distribution of products and content to Customers by Elias Wick.

“Party” or “Parties” means Elias Wick and/or you.

“Product” or “Products” means any of Elias Wick’s Content available on Gumroad. Product or Products also refers to any product developed under this Agreement.

“You”, “your” or “yourself”, whether or not capitalized in this Agreement, means you as an individual or the legal entity exercising rights under this Agreement through you. For legal entities, “you”, “your” and “yourself” include any entity that controls, is controlled by, or is under common control with you, where “control” means the power, direct or indirect, to cause the direction or management of the entity in question, whether by contract or otherwise, or ownership of 50% or more of the outstanding shares or beneficial ownership of the entity in question.
